2. Clearing agent licence details

According to the current licence issued by the **South African Revenue Service (SARS)**:

- **Licence type:** Customs Clearing Agent
- **Customs client number (clearing agent code):** CU21725569
- **Licensing authority:** South African Revenue Service (SARS), Customs & Excise
- **Licence status:** Approved and valid, subject to SARS rules and any licence conditions
- **Licence validity period:** 1 January 2026 – 31 December 2026

Sterdts (Pty) Ltd is authorised, in terms of this licence and applicable customs legislation, to act as a clearing agent for import and export customs declarations in South Africa, subject to SARS requirements and any conditions attached to the licence.

3. Scope of services as a customs clearing agent

Acting as a licensed customs clearing agent, Sterdts may, subject to our [Standard Trading Conditions \(STCs\)](#) and instructions from clients:

- Prepare and submit customs import and export declarations to SARS
- Liaise with SARS and other authorities on customs-related matters for client shipments
- Facilitate clearance of freight and household goods through South African ports, airports and border posts

- Coordinate with carriers, depots and other logistics providers for the movement and release of goods

Our role includes applying applicable customs procedures based on information and documents provided by clients and overseas partners. We may also work with approved third-party brokers where specialised expertise or capacity is required.

4. Important notes and limitations

- This confirmation is based on the **current SARS clearing agent licence** issued to Sterdts (Pty) Ltd and may be updated when SARS issues renewed or amended licences.
- All customs activities are subject to:
 - SARS legislation, regulations and policies; and
 - Any licence conditions that SARS imposes on clearing agents.
- Sterdts relies on clients to provide **accurate and complete information** about their goods, values, origin/destination and status. Incorrect or incomplete information can lead to penalties, delays or other consequences for which the client may remain responsible.
- This document does **not** guarantee any particular customs outcome (for example concession approval, duty-free treatment or release without inspection). Final decisions rest with SARS and other authorities.
